By signing this agreement, you affirm that you understand and agree to all policy's, procedures, and statements listed below. Wag Atlanta's group play combines day care dogs and boarding dogs who meet our group requirements and are placed in groups based on size and temperament. Intact males and aggressive dogs will not be permitted to participate in group. Groups play form 4-8 hours depending on factors such as weather. A team member is always with the groups monitoring behaviors. We DO allow these dogs to play like dogs. They will run, jump, and tussle with each other, many will do play mouthing around the neck as they tussle. This is mutual play. Wag Atlanta reserves the right to remove any dog from group as we see fit. Dogs are more likely to be injured while playing than while sleeping on your couch at home. There is a risk of injury. Wag Atlanta is not responsible for any injury. If an injury occurs, we will contact you, apply first aid as needed and take your dog to the vet if needed. Your dog will also go home tired. Typically, your dog would not be as active at home as they will be in our group. They will probably rest for the next day or more. Your dog may also lose weight, just as we lose weight when we are more active. If you feel your dog is likely to very active in group, you may want to increase the amount of food you give them per meal. Our group dogs have a fantastic time! Our goal is for them to enjoy their days and sleep well at night, with as little stress about being away from home as possible. Staying active is a terrific stress reliever. Wag Atlanta Boarding Kennel Agreement

This is a Contract between Wag Atlanta Pet Resort (hereinafter called "Kennel") and the pet owner whose signature appears below (hereinafter called "Owner") for services for _____ (hereinafter called "Pet").

Payment is required for services at the time of checkout. Owner agrees to pay the rate for boarding in effect on the date Pet is checked into the Kennel as posted on the Kennel's website. Pets checked out later than 4pm of their scheduled checkout date will be charged an extra \$15. Any pet picked up after 11:59pm of the checkout date will be charged an extra day boarding. Owner agrees to pay all costs and charges for special services requested, plus all veterinary expenses deemed appropriate by Kennel for Pet during the time it is in the Kennel's care. Kennel shall attempt to contact Owner before incurring such veterinary services as may be required by Pet's health and/or behavior.

Due to the social nature of our Kennel, there are some inherent risks. These risks may include, but are not limited to: transfer of communicable diseases such as Canine Papilloma virus (Puppy Warts), Canine Cough and Feline Upper Respiratory Infection. Injuries may include, but are not limited to: broken nails, sore feet, puncture wounds, abrasions, cuts, and bites. Owner agrees that kennel will in no way be held financially responsible for any injury. These injuries are generally benign and can usually be managed by our staff or at home. In some cases, veterinary care may be required.

Kennel shall exercise reasonable care for Pet delivered by Owner to Kennel for boarding. It is expressly agreed by Owner and Kennel that Kennel's liability shall in no event exceed fair market value for the Pet boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said Pet while it is in the care of the Kennel. Owner agrees to be financially responsible for kennel property damaged by Pet. Reasonable costs for damage will be payable upon checkout of Pet. If owner requests pets be boarded in the same space together, owner of pets is solely responsible for any injury that pets inflict upon each other.

Owner specifically represents to Kennel that Pet has not been exposed to rabies or distemper within a thirty-day period prior to boarding. Kennel requires proof of current Rabies, Distemper and Bordetella vaccinations. We require a Bordetella vaccination every six (6) months (intranasal), or every 1 year (intravenous). The Bordetella vaccine is not 100% effective. It is recommended that it be given to your dog at least two (2) weeks prior to Pet's arrival date to increase effectiveness. Kennel makes no guarantees in regards to the Bordetella vaccine. All pets are checked for external parasites (fleas/ticks) upon entry to the facility. If any external parasites are found, they will be treated accordingly and Owner will be responsible for those expenses.

If Pet becomes ill or if Pet's behavior is endangering itself, humans, or other animals, Kennel, in its sole discretion, may engage the services of a veterinarian. All attempts will be made to contact the Owner of the Pet first; however, in the event of an extreme emergency, the wellbeing of the Pet comes first. Medication will be administered as necessary under the direction of a veterinarian. Undersigned Owner hereby gives the veterinarian complete authority to treat Pet in whatever manner deemed necessary. Owner will be responsible for all veterinary charges upon release of the Pet. Owner also gives full authority for the treating veterinarian and their associates to discuss with Kennel any aspect of any illness or injury that the Kennel has presented for treatment.

Owner authorizes Kennel to use pictures of their Pet taken while participating in Kennel activities on its website, social media, and in other promotional materials. Owner also authorizes kennel to obtain medical and vaccination records for your dog from your veterinarian and hereby authorizes your veterinarian to provide these records to Wag Atlanta.

Owner acknowledges that Wag Atlanta does not accept pets into their care that are aggressive towards kennel staff, and towards other animals in kennel's care. If Pet is found to pose a danger to kennel staff or to other dogs/cats, owner will be notified and responsible for immediate pick up of Pet.

It is understood that dogs of a certain age are at an increased risk of injury and death. Owner understands that boarded geriatric and dogs older than 8 years old comes with inherent risk and agrees that kennel will not be held responsible if said pet passes away from natural causes (heart failure, heart attack, organ failure, etc.).

After a period of 48 hours past confirmed check out time with no contact either through email, phone, or Facebook messenger, we will assume that your pet has been abandoned, and execute steps as listed under O.C.G.A. § 44-14-490.

By signing this Agreement and leaving Pet with the Kennel, Owner certifies to the accuracy of all information given about Pet to the best of their knowledge. Owner specifically represents that he or she is the sole owner of Pet.

By signing this Agreement, Owner indicates that he or she has read and accepted all policies listed in this agreement as well as all policies on Kennel's Schedule of Services and Fees.

This contract contains the entire agreement between the parties and by signing below you agree that Wag Atlanta is NOT responsible for bedding, blankets, toys or other personal belongings damaged by your pet or our washing machines/dryers.
